## Regulations

The International Thialf Race 2022 will be held in accordance with the 2022 Regulations of the International Skating Union (ISU) and relevant ISU Communications.

#### **Track**

Thialf Ice stadium is an indoor artificially frozen ice rink with a standard track of 400 meters and inner and outer curves with radii of 26 and 30 meters respectively. The width of the inside training track is 4 meters.

### Participating / Entries

Participating in the International Thialf Race 2022 is open to Junior B, Junior A and senior skaters. The entries and participation are based on the "Rules training competitions KNSB-and top teams", as mentioned on <a href="https://knsb.nl/langebaan-kortebaan/topsportfaciliteiten-2/">https://knsb.nl/langebaan-kortebaan/topsportfaciliteiten-2/</a> and additional on invitation. However there are fixed spots for the KNSB to fill this competitions. The KNSB invites juniors to participate and guarantees the skaters a spot in the competition. This also applies to skaters that are actively participating in the ISU Centre of Excellence in Heerenveen.

The entry system of inschrijven.schaatsen.nl will be used accordingly.

Drawings will be made by the VANTAGE system.

#### Time measurement

Time measurements will take place by Electronic timekeeping and Manual timekeeping to determine the time and the order of finish of Skaters.
