This competition will serve as Qualifying event for the Olympic Winter Games 2014

## GENERAL REGULATIONS

The competitions will be conducted in accordance with the 2012 ISU Regulations and relevant Communications. Participation is open to all ISU Members. This competition is part of the Samsung ISU World Cup Short Track Speed Skating 2013/2014.

## DISTANCES

Individual: 500, 1000, 1500 meters Ladies and Men
Relay: $\quad 3000$ meters Ladies, 5000 meters Men

## TRACK CONDITIONS

The "PalaTazzoli" is a sport complex with two artificially refrigerated indoor ice surface of $60 \times 30$ meters. Protective padding covers the boards in accordance with Rule 280 - paragraph 5 and ISU Communication No. 1726.
The standard track will be laid out 111.12 meters to the lap.

b) Entries with the numbers of Competitors, substitutes, coaches \& team leader and requirements of accommodation, visa and meals service must be submitted by

## SEPTEMBER $\mathbf{2 6}^{\text {TH }}$, 2013

ISU Members failing to comply in time with these requirements will receive no support from the Organizing Committee for:

- HOTEL BOOKING;
- TRAVEL ARRANGEMENTS FROM AIRPORT TO HOTEL AND RETURN;
- TRAVEL ARRANGEMENTS FROM HOTEL TO ICE RINK AND RETURN;
- PREFERRED TIMES FOR ADDITIONAL TRAINING SESSIONS

All these costs and many additional costs incurred will be for the full account of the ISU Members concerned.
c) Final Entries must reach the Organizing Committee using the Online Entry System no later than November 2 ${ }^{\text {nd }} .2013$ (see ISU Communication 1802, paragraph 4), and the following information must be communicated to the Organizing Committee:

- Names of the Competitors and substitutes per category with their International Registration Numbers;
- Names of the Competitors for each of the respective individual distances;
- Confirmation of participation in the Relay

Final Entries that do not comply with these requirements are considered Post Entries. See Rule 115.
d) Competitors must be present in Torino at the latest at 18:00 hours on Wednesday $6^{\text {th }} .2013$ or the Organizing Committee must receive documented proof that the competitors are in transit and will arrive in due time for the World Cup Competition. Competitors who do not comply with these requirements will be excluded
e) Please note that for all persons entered by the Members, the procedures regarding the Declaration for Competitors and Officials (all team Officials requiring an accreditation) entering ISU Events (Rule 131) as outlined in ISU Communication No. 1628 need to be strictly observed.
For more details please refer to Rules 115, 131 and ISU Communication No. 1628 or any update of this Communication.

## ITALY ENTRY REQUIREMENTS

All entries in Italy must provide a valid passport at time of entry for all the Countries out of "Schengen Agreement". Some Countries may have to obtain a Visa in order to enter the Italy. Letters of invitation for those requiring a Visa should be requested to Federazione Italiana Sport del Ghiaccio such in advance of the event in order to allow time for processing.

## CITIZENSHIPS/RESIDENCE REQUIREMENTS AND CLEARANCE PROCEDURE

In accordance with Rule 109 of the ISU Regulations and ISU Communication No. 1420, all skaters who do not have the nationality of the Member by which they have been entered or who, although having such nationality, have in the past represented another Member, most procedure an ISU Clearance Certificate.

## SEEDING PROCEDURE

The make-up of the first qualifying round of each distance shall be based on the current distance ranking following the principles of Rule 296, of the 2012 ISU Regulations. Progression to subsequent qualifying rounds shall be according to Rule 295, paragraph 2.

## WORLD CUP POINTS

The points scoring at the World Cup Competition is made in accordance with ISU Communication No. 1802 paragraph 10.

## ANTI DOPING

Anti-Doping test will be carried out according to the ISU Anti-Doping Code, as given in the applicable ISU Communications. (ISU Communications Nos. 1693, 1694, 1765 and 1800 or later updates).

A team will be at the Hotel Rivoli to promote the Clean Skaters campaign and to answer any questions related to Anti-doping. All Skaters and members of the Skating Family are invited to pass by.

## ICE TRAINING

The Organizing Committee will arrange free ice training on Wednesday November $6^{\text {th }} 2013$ for all participating teams. Extra practices will be provided from Monday $4^{\text {th }}$ and Tuesday $5^{\text {th }} 2013$.
Each training session ( 50 mins ) will be charged 120,00 Euro. If two or more teams agree to share one training session, both (all) of them can share the cost.

## LIABILITY

In accordance with Rule 119 of the ISU General Regulations, the International Skating Union, the Federazione Italiana Sport del Ghiaccio and the Organizing Committee assume no responsibility for or liability with respect to bodily or personal injury or property damage incurred in connection with the ISU World Cup Short Track Speed Skating Competition.
Each Member is solely responsible for providing insurance coverage thereto.

The Teams, Coaches and Team Officials shall cover and pay their expenses for the hotel rooms and meals.
