ENTRIES/PARTICIPATION FIGURE SKATING – TEAM EVENT (SINGLE & PAIR SKATING AND ICE DANCE)

A) YOG Quota Places and Team Event

Further to the November 16 confirmation deadline, the following quota of entries for the Single & Pair Skating and the Ice Dance competitions at the 2024 Winter Youth Olympic Games (YOG) are as follows:

Further to these entries, the Team event entries have been awarded. In order to qualify fo the team Event, an NOC/ISU Member must have entries in at least three (3) categories (Women, Men, Pair Skating or Ice Dance).

The following NOCs/ISU Members therefore qualified for the Team Event:

- CAN
- CHN
- FRA
- KOR
- USA

To be eligible to participate in the Winter Youth Olympic Games Gangwon 2024, all male and female athletes must be born between 1 January 2006 and 31 December 2009.

ISU Members/NOCs are requested to take these age restrictions into account when confirming or rejecting YOG Quota Places and when entering the athletes.

Furthermore, only Skaters fulfilling both ISU and IOC citizenship/residency requirements may be entered. According to the Olympic Charter, Rule 41, only citizens of the NOC/ISU Member may be entered.

B) Entry procedures/deadlines

- November 15 December 15, 2023 ISU to reallocate unused quota places to ISU Members/NOCs on stand-by list who had confirmed interest in participation. ISU Members/NOCs being offered an unused Quota Place to react within 24 hours of receipt of the ISU notification.
- **December 11-12, 2023** ISU to publish a summary of NOCs/ISU Members qualified for the Team Event. NOCs/ISU Members must confirm the use of the allocated quota place withing 24 hours.
- **December 11-18, 2023** ISU to inform relevant NOCs/ISU Members regarding reallocation of Team quota places that will have to be confirmed by the NOC within 24 hours. Lack of an NOC response to the ISU within this deadline will be considered as a refusal of the offered Team Quota Place
- Until January 5, 2024 Entries by name by NOCs to be sent to the local YOG Organizing Committee with copy to ISU, to be entered by the ISU Member in ORS.
