7. Draw of the panels

In accordance with Rule 582, paragraph 6. f)-h), Rule 660, paragraph 6. f)-h) and Rule 972, paragraph 4.b), the panels will be drawn on site 45 minutes before the start of each segment.

Note:

In accordance with Rule 582 and 660, paragraph 4 d) and 972, paragraph 3b), entries by names must be forwarded to the Organizing Committee of the Respective Championships, to the Sports Director Figure Skating and to the ISU Secretariat, 45 days prior to the beginning of the Championships. Only the official forms, sent by the Organizing Committee to all Members, and signed by the President or General Secretary of the Member concerned will be accepted.

In accordance with Rules 582, paragraph 4 c) and Rule 660, paragraph 4 c), judges must not serve in more than one (1) discipline per ISU Championships.
