ISU JUDGES / REFEREES SEMINAR and ISU GLOBAL COACHES' SEMINAR

Berlin, GERMANY

The ISU Synchronized Skating Technical Committee (SySTC) has arranged for this year's ISU Judges / Referees seminar and an ISU Synchronized Skating Global Coaches' seminar as follows:

1. ISU Judges / Referees Seminar (September, 1 - 3, 2013)

Purpose:

This ISU Seminar will include a Judges section and a Referees section.

- the Judges section forms an ISU Seminar for re-appointment of International Judges and a seminar for National Judges;

- the Referees section forms an ISU Seminar for re-appointment of International Referees and ISU Referees.

Note:

Please note that at all 2011, 2012 and 2013 ISU Synchronized Skating Championships (ISU 2013 World Junior Synchronized Skating Championships, ISU World Synchronized Skating Championships), the Initial Judges Meetings and Round Table Discussion were conducted by a Member of the Synchronized Skating Technical Committee. Therefore each of those Initial Judges Meetings and the respective Round Table Discussion formed together an ISU Seminar for reappointment of ISU Judges, as per Rule 417, paragraph 5.

ISU Examinations for first appointment of International Judges and first appointment of International Referees and ISU Referees will be held in Frankfurt, Germany, in July, 2015.

Participants /Applications:

Each ISU Member may announce one or several Judges/Referees to attend by **August 21, 2013**. National Judges up to an agreed number may also participate in this seminar for the purpose of additional education. The application should indicate if the participant will attend the Referees Seminar, Judges Seminar, or both Seminars.

The number of participants is limited to 20. However a **minimum of 10 participants** is required. The selected participants will be notified of their acceptance after the deadline.
