7. Draw of the panels

In accordance with Rule 521, paragraph 6. e)-g) and Rule 971, paragraph 5.d), the panels will be drawn on site 45 minutes before the start of each segment.

Note:

In accordance with Rule 521, paragraph 4 d) and 971, paragraph 3b), entries by names must be forwarded to the Organizing Committee of the Respective Championships, to the Sport Manager Figure Skating and to the ISU Secretariat, 45 days prior to the beginning of the Championships on the official entry form for Judges by name and/or by entering the Judges by name through the Figure Skating Online Registration System (ORS).

In accordance with Rules 521, paragraph 4 c), judges must not serve in more than one (1) discipline per ISU Championships.
