ENTRIES/PARTICIPATION 2018 OLYMPIC WINTER GAMES (OWG) SINGLE & PAIR SKATING/ICE DANCE

A. Single & Pair Skating

Entries

Entries will be determined in accordance with Rule 400 A., of the ISU Special Regulations and Technical Rules Single & Pair Skating and Ice Dance 2016. The maximum number of entries for the Olympic Winter Games is thirty (30) for Ladies and Men and twenty (20) for Pair Skating (for the Host ISU Member please see separate chapter as below). There are two different ways to qualify for the 2018 Olympic Winter Games:

1. Accumulation of points according to Rule 378, paragraph 2. b) and c) for ISU Members which have participated in the immediately preceding year's ISU World Figure Skating Championships (Helsinki 2017).

According to Rule 400 A., paragraph 3, twenty-four (24) entries in the Single events (Ladies and Men) and sixteen (16) in the Pair Skating event will be determined according to the diagram outlined below. ISU Members with only one entry are listed in order of their best-placed Skater in the ISU World Figure Skating Championships 2017.

According to Rule 378, paragraph 2. b) and c), the number of Skaters per discipline (Ladies, Men, Pair Skating) an ISU Member may enter in the 2018 OWG is determined in accordance with the following diagram:

The above-mentioned points are calculated by the addition of placements at the ISU World Figure Skating Championships 2017. If three (3) Skaters participated in the ISU World Figure Skating Championships 2017, only the two (2) best placed count for points.

2. Remaining open entries: Rule 400 A., paragraph 4

According to Rule 400, paragraph 4, the remaining open entries available will be filled by ISU Members in order of their placements at a Senior International Competition designated by the ISU (Nebelhorn Trophy 2017, September 27-30, 2017, Oberstdorf/Germany). The open entries are available only to those ISU Members which have not previously earned an entry in the respective discipline (according to Rule 400, paragraphs 2 and 3) and only one (1) entry per discipline and ISU Member may be earned.

3. ISU Members having earned entries at the ISU World Figure Skating Championships 2017: Rule $400~\mathrm{A.}$, paragraph 7

ISU Members who have earned entries under the provisions of Rule 400 A., paragraphs 2 and 3, should, after consultation with their NOC (National Olympic Committee), inform the ISU Secretariat **not later** than 15 September 2017 if they intend to use their full quota of entries. In the case that some ISU

Members do not intend to use their full quotas of entries, the remaining open entries available will be filled by increasing the number of entries according to Rule 400 A., paragraph 4.

ISU Members not exercising the right to announce their participation: Rule 400 A., paragraph 8. In the event that ISU Members do not exercise their right to announce their participation within the prescribed IOC date limit in accordance with Rule 400 A., paragraphs 3 to 5, stand-by entries will be chosen, based on the final results of the Senior International Competition designated by the ISU (Nebelhorn Trophy 2017, September 27-30, 2017, Oberstdorf/Germany) for those ISU Members not qualified and not yet represented.

B. Ice Dance

Entries

Entries will be determined in accordance with Rule 400 A., ISU Special Regulations and Technical Rules Single & Pair Skating and Ice Dance 2016. The maximum number of entries for the Olympic Winter Games is twenty-four (24) (for the Host ISU Member please see separate chapter as below). There are two different ways to qualify for the 2018 Olympic Winter Games:

1. Accumulation of points according to Rule 378, paragraph 2 b) and c) for ISU Members which have participated in the immediately preceding year's ISU World Figure Skating Championships (Helsinki 2017).

According to Rule 400 A., paragraph 3, nineteen (19) entries will be determined according to the diagram outlined below. ISU Members with only one (1) entry are listed in order of their best-placed couple in the ISU World Figure Skating Championships 2017.

According to Rule 378, paragraph 2 b) and c), the number of couples an ISU Member may enter in the 2018 OWG is determined in accordance with the following diagram:

2. Remaining open entries: Rule 400 A., paragraph 4

C. Figure Skating Team Event

The ISU will inform ISU Members/NOCs after the ISU Grand Prix of Figure Skating Final 2017/18 (in Nagoya/JPN – December 7-10, 2017) regarding the qualified Teams for the Olympic Figure Skating Team Event.

D. Host Country entries

In accordance with Rule 400, in case the Host ISU Member went through the normal qualifying procedure and did not qualify under Rule 400 paragraphs 3 or 4 in any of the disciplines (Ladies, Men, Pair Skating, Ice Dance), the Host ISU Member shall have the right to enter one (1) Competitor per concerned discipline(s) as additional entry(ies) as long as the concerned Skater(s)/Pair/Couple achieved the Minimum Total Elements Score (points) for the Olympic Winter Games and places are available from the additional Athletes Ouota.

E. Referees, Technical Controllers, Technical Specialists, Judges, Data Operators, Replay Operators for Single & Pair Skating and Ice Dance for the OWG 2014

The Judges' draw in accordance with Rule 402, will be conducted on site of the ISU Olympic Qualifying Competition, Nebelhorn Trophy 2017 and is tentatively scheduled for September 30, 2017, in Oberstdorf/Germany.

All other Officials will be appointed in accordance with Article 16, paragraph 2.f) of the ISU Constitution, Rules 121, 126 paragraphs 8 and 9 and Rule 401.
