### Frankfurt Seminar 2021 – Cancelled Seminar Updates

Due to the cancellation of the Global Officials Seminar 2021 planned to take place in Frankfurt, Germany, the ISU offered some of the initially planned Seminars and Examinations online.

**1. RE-CERTIFICATION – Online participation of ISU and/or International Technical Controllers and/or Technical Specialists for re-certification initially nominated for the 2021 Frankfurt Seminar**

All re-certification for all disciplines were conducted online and the reappointment module was available on the ISU e-learning website [elearning.isu.org](https://elearning.isu.org).

Compliance to retain the Technical Panel Official's status was as follows:

Questionnaire: Discipline specific had to be taken as part of the compliance requirement

Element Identification: Examination dates between May 25 and July 10, 2021 were offered to the Candidates.

Candidates could utilize any examination date. Candidates who are both Single and Pair Skating qualified only had to take the Pair Skating re-certification module to remain compliant for both disciplines.

**2. “NEW” INTERNATIONAL TECHNICAL CONTROLLERS AND/OR TECHNICAL SPECIALISTS  
Nomination of ‘new’ International Technical Controllers and/or Technical Specialists to the Frankfurt Seminar**

All Candidates accepted for the 2021 Seminar will be automatically accepted for the 2022 Global Seminar with a tentative date of July 2022. Additional requirements will not be needed for these 2021 accepted Candidates, provided they still fulfill the age requirements as stated in Rule 414 for Technical Controller Candidates and Rule 415 for Technical Specialist Candidates.

New Candidates for the 2022 Seminar; however, will need the required application and supportive documents for consideration.

**3. PROMOTION TO BECOME AN ISU TECHNICAL CONTROLLER OR TECHNICAL SPECIALIST  
Nomination of International Technical Controllers and/or Technical Specialists for promotion to become an ISU Technical Controller or ISU Technical Specialist**

All Candidates accepted for the 2021 seminar will be automatically accepted for the 2022 Global Seminar with a tentative date of July 2022. Additional requirements will not be needed for these accepted Candidates, provided they still fulfill the age requirements as stated in Rule 414 for Technical Controller Candidates and Rule 415 for Technical Specialist Candidates.

New Candidates for the 2022 Seminar; however, will need the required application and supportive documents for consideration.

All Promotion Candidates needing to remain compliant for their current status will need to take the re-certification questionnaire and element identification examination.
